**2ND INVITATION TO BID FOR
A SPORTS UTILITY VEHICLE FOR THE EMBASSY**

1. The *Embassy of the Republic of the Philippines in Kuwait*, through the *authorized appropriations under the General Appropriations Act of FY 2015*, intends to apply the sum of *One Million Six Hundred Thirty Two Thousand (P1, 632,000.00) approximately US\$35,439.74*, being the *Approved Budget for the Contract (ABC)* to payments under the contract for the *acquisition of Sports Utility Vehicle with an engine displacement not exceeding 2700cc, gasoline-fed or 3000cc, diesel-fed*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Embassy of the Republic of the Philippines in Kuwait Bids and Awards Committee* now invites bids for the said project described as follows:

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the *Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184*, otherwise known as the “*Government Procurement Reform Act*”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the *IRR of RA 9184*.

4. Interested bidders may obtain further information from *Embassy of the Republic of the Philippines in Kuwait Bids and Awards Committee* and inspect the *Bidding Documents* at the address given below from *29 November 2015 (Sunday) to 7 December 2015 (Tuesday)* at *8AM to 5PM*.
5. A complete set of *Bidding Documents* may be purchased by interested Bidders on *29 November 2015* from the address below and upon payment of a nonrefundable fee for the *Bidding Documents* in the amount of *US\$65.00*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. Bids must be delivered to the address below on or before *1 December 2015*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on *8 December 2015* at *the Philippine Embassy Chancery*. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The *Embassy of the Republic of the Philippines, Bids and Awards Committee* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
